Cat Boarding Contract

(hereinafter called the "Owner"). The term "cat" refers to all cats boarding with the same ownership

Please read carefully and initial each item.	
1. Owner understands that the boarding fee is charged on a per night basis. Check IN is from 1:00 M to 3:00 PM. Check OUT is from 9:00 AM to 11:00 AM. Both by appointment only. If an ppointment is needed outside of these times, fees may apply. If appointments are missed, with no otification, fees may apply.	
2. Owner understands that Mau House is not a 24-hour facility. Rooms are not monitored between 7 pm and 7 am. Cats requiring overnight care, or medical monitoring or services need to be loarded at a 24-hour facility. Owner asserts that all known medical and behavioral history of cat has seen disclosed to Mau House before boarding.	
3. Owner understands that Mau House staff is not a veterinarian or registered veterinary echnician. Mau House does not board any cats with medical conditions other than those stable with basic medications	
4. Owner understands that extra charges may be added to the bill at the discretion of nanagement for special handling or treatment that is above and beyond routine care, i.e. an nexpected bath, etc. Special handling is defined as services beyond our standard boarding care due to behavioral problems, excessive accidents, health issues, or other unexpected care not anticipated t time of check in. Owner agrees to pay all such charges.	
5. Mau House recommends providing enough of your cat's food for their stay, plus a bit extra. Owner understands that if Mau House has to supply food, there will be an additional charge per lay per cat. Owner also understands that a change in food may result in digestion upset.	
6. All cats entering Mau House must be clean and flea free. If upon inspection, this is not the case, lea control will be given at the Owner's expense.	
7. Owner understands that cats may be sensitive to a change in environment and even though ersonal attention & care is given to all cats, this change in environment may be just enough to lead o stress induced disease or underlying medical condition to be presented.	

8. Owner represents that cat is healthy and has not been exposed to any known communicable disease within thirty- day period immediately prior to boarding. Owner agrees to disclose to Mau
House all known medical conditions and/or behavior problems, which may affect cat's care prior to
check in. Owner shall inform Mau House of any changes in cat's condition and behavior at or prior to
check in for all subsequent boarding stays.
9. Mau House requires all pets to be vaccinated. Rabies and FVRCP are required to board. The
only exception is in elderly cats. Mau House would need notification from Owner's veterinary
professional.
10. Owner releases Mau House from, and waives all claims and liability against Mau House for,
damage to, or loss of, personal equipment or belongings provided by Owner for cat while the cat is
boarded. Items not taken home at checkout will be donated if not picked up within 60 days of check
out date.
11. Owner understands that Mau House reserves the right to refuse service due to cat's
behavior or health, excessive cancellations, no shows, or late arrivals, non-payment, or violations
of said contract.
12. Owner understands that Mau House will do all it can to ensure that owner's cat will have a
safe and enjoyable boarding experience. Owner has signed an emergency treatment form provided
by Mau House, which is a part of this contract.
13. Occasionally, photographs or video footage may be taken of cats that are staying at Mau House Dwner gives permission for any resulting photographs or video of Owner's cat/s to be used for
advertising or educational material, understanding that the resulting photographs or videos are the
sole property of Mau House.
14. If cat is not picked up by Owner at the agreed time, Owner authorizes Mau House to continue
o provide the daily services set forth in this contract at Owner's expense. Notwithstanding the
oregoing, if the cat is not picked up within 14 calendar days after the day the cat was initially due to be
picked up, the cat shall be deemed to be abandoned, and Mau House shall have all rights set forth in Section 1834.5 of the California Civil Code.
